On June 21, 2004, Age Research, Inc. (the "Company") acquired all of the issued and outstanding capital stock of SalesWare, Inc. in exchange for the issuance of 7,000,000 shares of the Company's common stock to the shareholders of SalesWare, Inc. As a SalesWare, Inc. shareholder, Mr. Noonan received 2,000,000 shares of the Company's common stock in connection with the stock transaction. On June 22, 2004, the Company acquired substantially all of the assets and liabilities of CRM SalesWare, Inc. through the Company's subsidiary, xSellsys, Inc. in exchange for the issuance of 7,500,000 shares of the Company's common stock to CRM SalesWare, Inc. CRM SalesWare, Inc. has distributed those shares to its shareholders, including Mr. Noonan, who received 1,041,475 shares. As a result of the consummation of CRM SalesWare, Inc. asset purchase transaction, Mr. Noonan became a ten percent shareholder of the Company.
